I shoot an unlimited number of high resolution images for **up to 4 hours of total time.**  
Includes 1 High Resolution CD-ROM or DVD of all images in JPEG format

### **SWEETHEART \$1000 (5 hours)**

I shoot an unlimited number of high resolution images for **up to 5 hours of total time.**  
Includes 1 High Resolution CD-ROM or DVD of all images in JPEG format

### **CELEBRATION \$1100 (6 hours)**

I shoot an unlimited number of high resolution images for **up to 6 hours of total time.**

## TERMS

It is understood that Leigh-Ann Wheeler is the exclusive official photographer retained to perform the photographic services requested on this Contract.

No part of any order, including proofs or CD-Rom, will be delivered until the balance is paid in full.

The Photographer reserves the right to use images for advertising, display, publication or any lawful purposes.

Upon signature, the Photographer shall reserve the time and date agreed upon, and will not make other reservations for that time and date. For this reason, unless the Photographer is able to fully replace the cancelled reservation, all deposits are non-refundable, even if the date of the wedding is changed or the wedding is cancelled for any reason.

If the Photographer cannot perform this Contract due to fire or other casualty, strike, act of God, or other cause beyond the control of the parties, or due to Photographers illness or emergency, then the Photographer shall return the deposit to the Client but shall have no further liability with respect to the Contract. This limitation on liability shall also apply in the event that photographic materials are damaged in processing, lost through camera malfunction, lost in the mail, or otherwise lost or damaged without fault on the part of the Photographer. In the event the Photographer fails to perform for any other reason, the Photographer shall not be liable for any amount except that which was paid.

The charges in this Contract are based on the Photographers Standard Price List. This price list is adjusted periodically and future orders shall be charged at the prices in effect at the time when the order is placed.

This Contract incorporates the entire understanding of the parties. Any modifications of this Contract must be in writing and signed by both parties.
